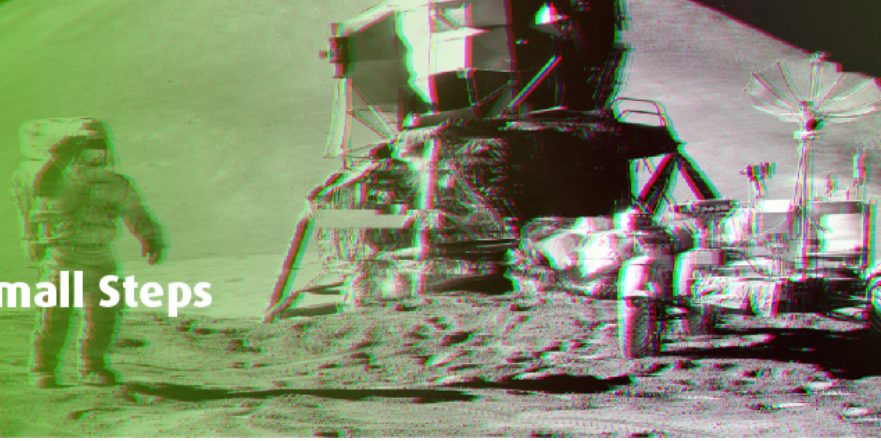

### Online conference experience

3. How is the transition to the **Cloud based Platform Services** envisioned, regulated and managed by the governments?

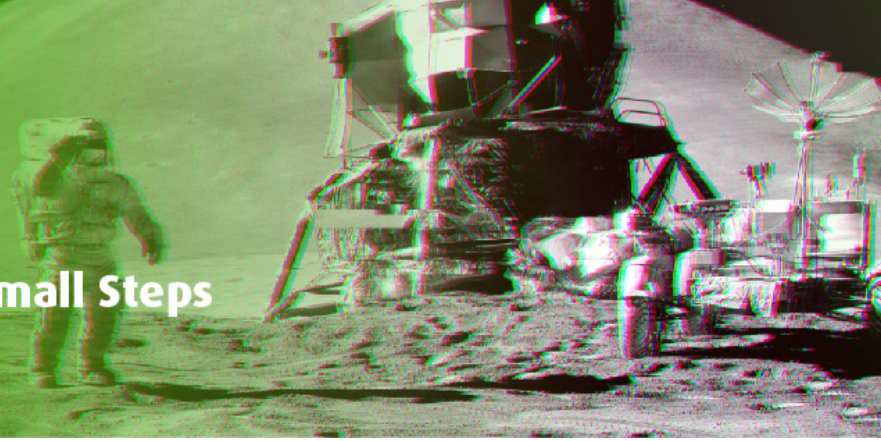

- 20<sup>th</sup> May The keynote presentation on topic 2 with expert feedback will be published. Two live online Q&A sessions on topic 2 will take place.
- 21<sup>st</sup> May The keynote presentation on topic 3 with expert feedback will be published. Two live online Q&A sessions will take place.  
The summary of the conference will be published.

The keynote sessions, Minister's and expert opinions will have Russian subtitles.

### Expo hall

The conference will also include a virtual EXPO where companies and organisations have a presentation space and can have interactive discussions with conference attendees to generate leads.

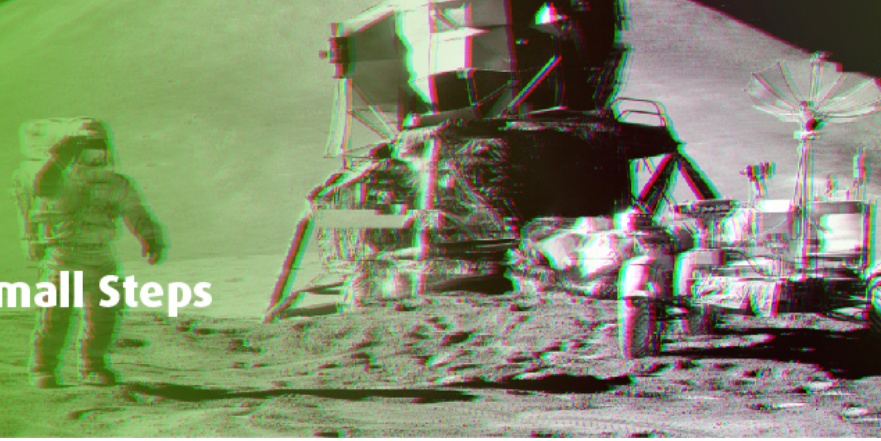
